Reconsideration Process

An applicant will be notified in writing should their request for destruction be denied and supplied with the reason for refusal. The applicant has the right to request a review of this decision by submitting a written reconsideration request, within 60 days of the date of refusal, to the Records Inspector. Further information to support the reconsideration request must be submitted, along with any court transcripts considered appropriate to substantiate the applicant's position.

Consideration will be given to each reconsideration request. After balancing the evidence and circumstances, the Reconsideration Panel shall form an opinion with respect to the destruction. The applicant will be notified of the decision in writing.

Personal Information contained in this form is collected pursuant to the *Municipal Freedom of Information and Protection of Privacy Act, s. 28(2)* and the *Community Safety & Policing Act, s. 80*, for the purpose of processing this request for the destruction of fingerprints, photographs and non-conviction dispositions.

NOTE: Destruction of fingerprints and photographs does not guarantee the applicant access to the United States – this is solely at the discretion of U.S. authorities.
